

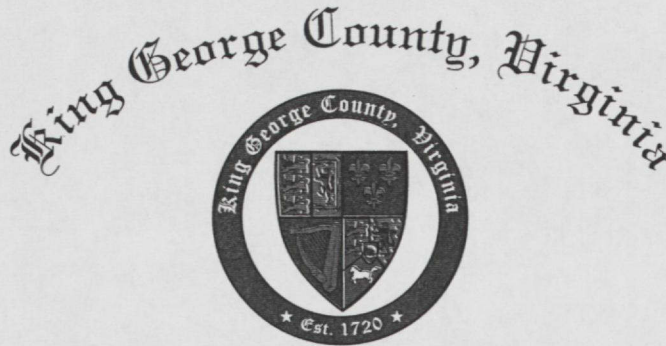

WHEREAS, the streets described on the attached Additions Form AM-4.3, fully incorporated herein by reference, is shown on a plat recorded in the Clerk's Office of the Circuit Court of King George County; and

WHEREAS, the Resident Engineer for the Virginia Department of Transportation has advised this Board the streets meet the requirements established by the Subdivision Street Requirements of the Virginia Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED that the King George County Board of Supervisors does hereby request that the Virginia Department of Transportation add the streets in North Ridge Estates Subdivision as described on the attached Additions Form AM-4.3 to the secondary system of state highways, pursuant to Sec. 33.1-229, Code of Virginia, and the Department's Subdivision Street Requirements;

AND FURTHER BE IT RESOLVED that this Board does guarantee the Commonwealth of Virginia a clear and unrestricted right-of-way of 50 feet with necessary easements for cuts, fills and drainage.


