### **Formation of the Department of Social Services as a Deviating Agency from the State of Virginia**

- DSS and King George County's Human Resources had an initial meeting and continue to research potential deviations. There will be regular meetings going forward.

### **Zoning Ordinance Overhaul**

- The next step in the process will be the Joint Work Sessions with the Board and Planning Commission in August and September.

### **Re-Assessment Committee**

- Mr. Miller and Ms. Lackey met with Judy Hart and Regina Puckett on July 13. They have some recommendations for possible implementation in 2024.

### **Expansion of Purkins Corner Convenience Center**

- A meeting will be held on August 03, 2023, between personnel from Waste Management and the County to continue discussions on the proposed 21<sup>st</sup> Amendment to the Host Agreement. When completed it will include a timeline for the expansion.

### **Phase II Middle School Turn Lane**

- The 2nd phase of the turn lane project will be performed after receiving Revenue Sharing funding approval (a Revenue Sharing Application was approved). VDOT has informed the County that funding will be available in 2024.
