



RESOLUTION AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE A
COOPERATIVE PARTNERSHIP AGREEMENT TO SUPPORT A REGIONAL APPLICATION
TO THE OPIOID ABATEMENT AUTHORITY FOR REGIONAL OPIOID
ABATEMENT EFFORTS

WHEREAS, the Opioid Abatement Authority (OAA) has among its responsibilities the task of allocating settlement proceeds not designated to particular localities on the basis of regional projects; and

WHEREAS, the Rappahannock Area Community Services Board (RACSB) has proposed a project to administer on behalf of King George and other jurisdictions of Planning District 16 that would provide a Mobile Medication Assisted Treatment (MAT) Program for a five year term whereby licensed providers would be retained along with transportation and supplies to visit each jurisdiction at least once a week to provide inductions, drug screens, medication administration, case management, counseling, peer support, and other services; and

WHEREAS, the proposed local match to enhance the grant scoring criteria for the regional MAT is allocation by each jurisdiction of a share of direct proceeds from opioid settlement proceeds to reimplement funding and enhance medical detox services at Sunshine Lady House for Wellness and Recovery for those experiencing a mental health crisis in conjunction with substance abuse which was discontinued by RACSB in 2020 due to lack of funding; and

WHEREAS, a Cooperative Partnership Agreement signed by participating localities is a required component of the OAA Cooperative Partnership Grant application; and

WHEREAS, it is anticipated that a single member jurisdiction will serve as the primary grant applicant and fiscal agent for the grant program if the project is selected for funding by the OAA.


