



**RESOLUTION TO AMEND THE PREVIOUSLY ADOPTED
REGULAR MEETING SCHEDULE FOR THE KING
GEORGE BOARD OF SUPERVISORS FOR CALENDAR
YEAR 2023**

WHEREAS, Virginia Code Section 15.2-1416 provides that the days, times and places of regular meetings to be held during the calendar year fixed by the Board of Supervisors of the County of King George, Virginia, at its annual meeting may be amended by subsequent resolution; and

WHEREAS, the Board generally conducts two regularly scheduled meetings during each month during calendar year 2023, but due to holidays and other public meetings, dates for single regular meetings in months of July and November were fixed with location to be determined; and

WHEREAS, the attachment to the prior resolution inadvertently set the meetings for the month of August on days other than the first and third Tuesdays of that month.

NOW THEREFORE, BE IT RESOLVED that the regular meetings of the Board for calendar year 2023 be held as follows:

1. Regular meetings of the Board shall be conducted on the first and third Tuesdays of each month at 6:30 pm at the Revercomb Building Board Room located at 10459 Courthouse Dr., King George, Virginia 22485, except as may be otherwise provided below or in the attached calendar (revised from the attachment to the January 3, 2023 resolution).
2. In the months of July and November, a single regular meeting shall be conducted for each month on the second Tuesday of those months at 6:30 pm at the Revercomb Building Board Room located at 10459 Courthouse Dr., King George, Virginia 22485.
3. In the event that the Chair (or Vice-Chair if Chair is unable to act) determines that cancellation of a scheduled meeting is warranted by weather or other hazardous conditions as further provided in the bylaws, such meeting shall be automatically rescheduled for the following Tuesday, unless the Chair (or Vice-Chair if Chair is unable to act) determines that emergency conditions persist, in which case the meeting may be further rescheduled to the next scheduled regular meeting date. All hearings and other matters previously advertised for a canceled meeting shall be conducted at the next convened meeting without requirement of further advertisement.


