



**RESOLUTION TO ADOPT A REGULAR MEETING  
SCHEDULE FOR THE KING GEORGE BOARD OF  
SUPERVISORS FOR CALENDAR YEAR 2023**

**WHEREAS**, Virginia Code Section 15.2-1416 provides that the days, times and places of regular meetings to be held during the calendar year shall be established by the Board of Supervisors of the County of King George, Virginia, at its annual meeting; and

**WHEREAS**, the Board intends to conduct two regularly scheduled meetings during each month during calendar year 2023, subject to cancellation or rescheduling of regular meetings, and addition of special meetings, as permitted by law and the bylaws as may be adopted at this annual meeting;

**NOW THEREFORE, BE IT RESOLVED** that the regular meetings of the Board for calendar year 2023 be held at the Revercomb Building Board Room located at 10459 Courthouse Dr., King George, Virginia 22485 as follows:

1. Regular meetings of the Board shall be conducted on the first and third Tuesdays of each month at 6:30 pm, except as may be otherwise provided in the attached calendar.
2. In the event that the Chair (or Vice-Chair if Chair is unable to act) determines that cancellation of a scheduled meeting is warranted by weather or other hazardous conditions as further provided in the bylaws, such meeting shall be automatically rescheduled for the following Tuesday, unless the Chair (or Vice-Chair if Chair is unable to act) determines that emergency conditions persist, in which case the meeting may be further rescheduled to the next scheduled regular meeting date. All hearings and other matters previously advertised for a canceled meeting shall be conducted at the next convened meeting without requirement of further advertisement.


