



APPEARANCE RELEASE

This Appearance Release (the "**Agreement**"), dated as of _____ (the "**Effective Date**") is to grant King George County, a political subdivision of the Commonwealth of Virginia (the "**County**"), the right to use the appearance of _____, the individual named below ("**I**," "**me**," or "**Participant**"), in connection with County's Photo Of The Year Contest 2023 (the "**Work**"). Participant agrees as follows:

I irrevocably give _____ (the "**Contestant**") my permission, and grant to the Contestant the right to film, record, and photograph me (the "**Images**") for the purpose of submitting the Images to the King George County Photo of the Year Contest 2023. I acknowledge that I am at least 18 years of age. If I am not at least 18 years of age, a parent or legal guardian with the authority to enter the contest on my behalf has signed below.

I grant the County the right to edit, display, reproduce, otherwise use, and permit others to use my name, image, likeness, and appearance in the Images and the Work in any format on any platform in perpetuity, without further consent from me or compensation to me. I also authorize the County to identify me by name, and use my name, likeness, and appearance in connection with the Work for advertising and promotional purposes without further consent from me or compensation to me.

I understand that the County has no obligation to use or promote the Images or the Work. I understand that I have no right to review or approve of the County's use of the Images or the Work before they are used. The County has no liability to me for alteration of the Work or Images. Any acknowledgement or credit of me shall be determined in the County's sole discretion.

I attest that no third party's rights are in conflict with my participation in the Work and no third party's permission is needed for my participation in the Work. I waive and release all legal and equitable rights to all claims, damages, and expenses related to my participation in the Work. Any matter related to my participation in the Images and the Work will be heard in King George County in accordance with the laws of the Commonwealth of Virginia.
