## RESOLUTION TO RATIFY THE FISCAL YEAR 2024 BUDGET AS APPROPRIATED JUNE 20, 2023

**Whereas**, it is the responsibility of the Board of Supervisors of King George County to approve and control the County's budget for fiscal year 2024 (June 1, 2023 to June 30, 2024); and

**Whereas**, the Board of Supervisors received comments on the recommended operating budget from the citizens of King George County at a duly advertised public hearing which was held on June 6, 2023; and

**Whereas**, by separate resolutions the Board of Supervisors adopted appropriation resolutions for the County and for the King George County School Board for fiscal year 2024 on June 20, 2023 that recited the amount of an approved operating budget with itemized and/or classifications of particular expenditures; and

**Whereas**, no separate action was taken to approve the operating budget as described in the appropriation resolutions, although the action item in the June 20, 2023 agenda packet indicated the intent to both adopt and appropriate the proposed operating budget, and, the budget recited in the appropriation resolution matched the budget description previously advertised for public hearing.

**Now Therefore Be it Resolved By** the King George County Board of Supervisors that the approved operating budget as presented in the appropriation resolutions on June 20, 2023 and as described herein, be ratified as the adopted budget for fiscal year 2024.
