



**RESOLUTION TO ESTABLISH A REASSESSMENT
ADVISORY COMMITTEE TO ASSIST WITH TASKS
ASSOCIATED WITH 2025 REASSESSMENT**

WHEREAS, pursuant to Virginia Code Section 15.2-1411, the governing body of any locality may appoint such advisory boards, committees, and commissions as it deems necessary to advise the governing body with regard to any matter of concern to the locality; and

WHEREAS, appointees serve at the pleasure of the governing body, be uncompensated, and perform such advisory functions as specified by the governing body; and

WHEREAS, the King George County Board of Supervisors wishes to create such an advisory committee to be known as the Reassessment Advisory Committee to advise the Board regarding the 2025 General Reassessment of King George County; and

WHEREAS, the committee shall consist of a minimum of five employees or citizens and a maximum of seven employees or citizens but employees other than committee members may provide reasonable technical or administrative assistance to the committee; and

WHEREAS, absent further action by the Board of Supervisors, the committee members' terms shall end at the time the informal hearings by the reassessment contractor are mailed to property owners.

NOW THEREFORE, BE IT RESOLVED that the King George County Board of Supervisors establishes a Reassessment Advisory Committee to act in an advisory capacity to the Board to provide input on the solicitation of a reassessment contractor, suggest drafting of public notices concerning the reassessment, and provide suggestions or sampling to assist with quality control of the reassessment contractor's performance (subject to legal confidentiality restrictions and not to be duplicative of work of the Board of Equalization); and

BE IT FURTHER RESOLVED that members shall include the Communications and Community Engagement Coordinator, the Commissioner of Revenue Office's Real Estate Specialist, and three or more citizens with preferred training or expertise from one of the following industries: finance or banking, real estate or title agency, and agriculture;

BE IT FURTHER RESOLVED that members shall be appointed after an application or nomination process with the Commissioner of Revenue having an opportunity to review and comment on the candidate pool.


