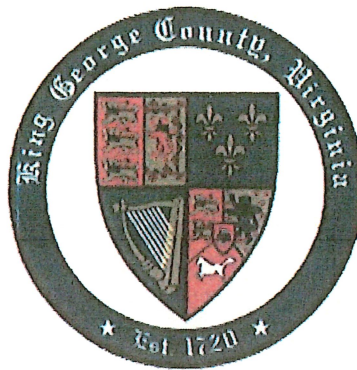

To Applicants requesting the Veteran Real Estate and Personal Property Exemption:

Attached is the application that must be completed to apply for the Veteran's Real Estate and Personal Property Tax Exemption for King George County. When completing the paperwork for this office, you **MUST** provide the letter from the Department of Veteran's Affairs that declares your disability. The letter must state 100% service-connected permanently and totally disabled. A sample letter is enclosed for you to reference.

You must bring the original letter to this office, along with the completed application you received from this office, photo identification for you and your spouse if married (must be your Veteran's ID/Spouse Dependent ID or marriage certificate), and a current utility or cable bill showing your dwelling location address.

VA State Code 58.1-3212 states, any county, city, or town that pursuant to this article provides for the exemption from, deferral of, or a combination program of exemptions from and deferrals of real property taxes may exempt or defer the real property taxes of the qualifying dwelling and the land, not exceeding ten acres, upon which it is situated.

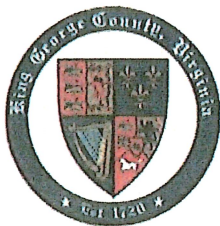
VA State Code 58.1-3668 states, "motor vehicle" means only a passenger car or a pickup or panel truck, owned and used primarily by or for a veteran of the Armed Forces of the United States or the Virginia National Guard who has been rated by the U.S. Department of Veterans Affairs or its successor agency pursuant to federal law with a 100 percent service-connected, permanent, and total disability shall be exempt from taxation. Any such motor vehicle owned by a married person may qualify if either spouse is a veteran who is rated as 100 percent disabled. Any locality may establish procedures for a veteran to apply for the exemption and may enact any ordinance necessary for administration of the exemption.

This exemption shall be applicable beginning on the date the motor vehicle is acquired or January 1, 2021, whichever is later, and shall not be applicable for any period of time prior to January 1, 2021. The exemption shall expire on the date of the disabled veteran's death and shall not be available for his surviving spouse. The Commissioner of the Revenue Office will mail a letter to each Veteran that is in the program at the beginning of each year to allow the Veteran to choose which vehicle is receiving the personal property tax exemption. If the letter is not received back in the Commissioner of the Revenue office prior to the generation of the bills, a vehicle will be chosen for the Veteran and an update can be made the following year.

QUALIFICATIONS

- Disability of Veteran must be total, permanent and 100% service connected
- Property must be Veteran's primary residence
- Spouse must be included on the Exemption packet (if applicable)
- Vehicle Must be used primarily by or for the Veteran (Personal Property Exemption expires on the death of the veteran)

If the Veteran is deceased, the surviving spouse may qualify for Real Estate Tax exemption if the following statements are true

- Veteran died on or after January 1, 2011
- Surviving spouse is not remarried
- Property is the surviving spouse's primary residence

REQUIREMENTS

- Exemption application completed and signed by Veteran and spouse
- Copy of letter from Department of Veterans Affairs stating 100% service connected disability
- Photo Identification for Veteran and Spouse (Only Veteran's ID/Dependent ID Accepted or Marriage Certificate)
- Proof of residence occupancy, such as a utility bill or cable bill. (For Real Estate Exemption)
- Copy of Veteran's death certificate (if applicable) presented by Spouse

Pursuant to Article X, Section 6-A of the Constitution of Virginia, the General Assembly exempted from Real estate taxation, the property which is the primary residence of any veteran and their spouse who has been rated to have a total, permanent and 100% service connected disability.

Upon completion of this packet and its acceptance by the King George County Commissioner of the Revenue, King George County will exempt from real estate taxation the parcel which is the primary residence of the Veteran and/or the surviving spouse of the Veteran up to ten acres pursuant to VA State Code 58.1-3212.

Pursuant to subdivision (a)(8) of Article X, Section 6 of the Constitution of Virginia, one motor vehicle owned and used primarily by or for a veteran of the Armed Forces of the United States or the Virginia National Guard who has been rated by the U.S. Department of Veterans Affairs or its successor agency pursuant to federal law with a 100 percent service-connected, permanent, and total disability shall be exempt from taxation. Any such motor vehicle owned by a married person may qualify if either spouse is a veteran who is rated as 100 percent disabled. Any locality may establish procedures for a veteran to apply for the exemption and may enact any ordinance necessary for administration of the exemption.

This exemption shall be applicable beginning on the date the motor vehicle is acquired or January 1, 2021, whichever is later, and shall not be applicable for any period of time prior to January 1, 2021. The exemption shall expire on the date of the disabled veteran's death and shall not be available for his surviving spouse. VA State Code 58.1-3668

The Veteran must re-certify and/or update their records with the Commissioner of the Revenue office if any of the following occur: changes in residence, name, ownership, purchase or disposal of vehicle, or percentage of service-connected evaluation.
