
FOG BMP will send you an invitation via eMail, for you to register and gain access the FOG BMP online Dashboard:

- Detailed profiles of all pumping companies approved to haul waste within our jurisdiction.
- Detailed profiles of waste disposal facilities.
- Provide platform for pumping companies to create and submit detailed grease trap cleaning records for our FOG generating facility clients.
- Perform FOG inspections at the FOG generating facilities within our County.
- Track sewer system overflows in our Wastewater Treatment Plants.
