RESOLUTION

FOR ACCEPTANCE OF A MAJOR AMENDMENT TO THE KING GEORGE COUNTY SOLID WASTE MANAGEMENT PLAN

WHEREAS Section 10.1-1411 of the Code of Virginia authorizes the Virginia Waste Management Board to promulgate regulations specifying requirements for local and regional solid waste management planning, and

WHEREAS the Virginia Waste Management Board has promulgated such regulations entitled, "Solid Waste Planning and Recycling Regulations (the Regulations), as 9 VAC 20-130 et seq., through the Virginia Department of Environmental Quality, and

WHEREAS the King George County Planning Region consists of the County of King George, and

WHEREAS the original King George County Solid Waste Management Plan (the Plan) was approved King George County and submitted to the Virginia Department of Environmental Quality (VDEQ) and approved by VDEQ on November 12, 2008, and

WHEREAS the Regulations set forth criteria for identifying amendments to the Plan under 9VAC20-130-175 and hence a major amendment to the Plan is required as there is an increase in landfill capacity. On December 28, 2016, the Virginia Department of Environmental Quality – Northern Regional Office approved a major permit modification to the King George County Landfill and Recycling Center increasing the capacity of the landfill from 45 million cubic yards to 67 million cubic yards. This permit was approved after appropriate public input on the permit application and draft permit. Approval of this permit necessitates a major amendment submittal to DEQ relative to the SWMP.

WHEREAS the Regulations establish a process for public participation for approval of major amendments under 9VAC20-130-130, and

WHEREAS King George County has enlisted the services of TRC Companies to complete the major amendment to the Plan - Document entitled "King George County – Solid Waste Management Plan – Major Amendment and 2023 Certification Update" dated March 15, 2024, and

WHEREAS the County has provided time for the public to review and comment on the major amendment to the Plan and held a public hearing relative to the Plan on April 2, 2024, and



NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of King George County has reviewed the major amendment to the Plan and held the appropriate public hearing at their meeting in regular session on **April 2, 2024**, and through its approval of the major amendment to the Plan authorizes its submittal to the Virginia Department of Environmental Quality.
