

Public Notice of Public Hearing for Special Exception Permit to Construct a Medium Scale Solar Facility

Application Z-2024-00219, Davis Hill Development/Daisy Lane Solar: Representatives from Davis Hill Development (applicant) and Jen Chiang (property owner) have applied for a Special Exception permit to construct a Medium Scale Solar Facility on approximately 14 acres zoned A-2, located at 8209 Daisy Lane, and further identified as Tax Parcel 15-16.

The Planning Commission considered this application at their meeting on April 8, 2025, and voted 8:1 to forward a recommendation of approval to the Board of Supervisors.

Pursuant to Virginia Code 15.2-2204 et. seq., the King George County Board of Supervisors will hold a Public Hearing on Tuesday, June 03, 2025, at 5:30 PM in the Boardroom of the Revercomb Building at 10459 Courthouse Drive, King George, VA, 22485.
