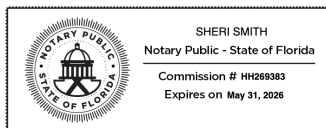

## **NOTICE OF PUBLIC HEARING OF KING GEORGE COUNTY BOARD OF SUPERVISORS**

Notice is hereby given that a public hearing will be held on Tuesday, June 03, 2025, at 5:30 PM, at the Revercomb Administration Building Boardroom, 10459 Courthouse Drive, King George, VA 22485, by the King George County Board of Supervisors to consider approval of Ordinance Amendment OA-01-25, Amendment to the King George County Zoning Ordinance (Section 4-7-1). To allow increased building heights of greater than 50 feet in the Industrial Zoning Districts upon issuing a Special Exception Permit.

On May 13, 2025, by a vote of 6-2, the King George County Planning Commission approved by resolution that the ordinance amendment OA-01-25 shall be forwarded to the King George County Board of Supervisors with a recommendation of approval.

Persons may appear and present their views at the public hearing.
