

# NOTICE OF PUBLIC HEARING OF KING GEORGE COUNTY BOARD OF SUPERVISORS

## KING GEORGE COUNTY, VIRGINIA NOTICE OF PUBLIC HEARING ON RECOMMENDED CALENDAR YEAR 2025 TAX RATES

The Board of Supervisors of King George County will hold a public hearing on the proposed Calendar Year 2025 tax rates at 5:30 p.m. on Tuesday, May 06, 2025, at the Horace A. Revercomb Administration Building Board Room, 10459 Courthouse Drive, King George, Virginia, 22485.

The tax rates below have been approved for advertisement by the Board of Supervisors.

The Board of Supervisors has the right to adopt tax rates equal to or lower than those advertised below:

### **The proposed Calendar Year 2025 King George County tax rates are as follows:**

1. Real Estate – No change to the current rate of \$0.68 per \$100 of assessed valuation based on 100% of market value is proposed.
2. Tangible Personal Property –No change to the current rate of \$3.25 per \$100 of assessed valuation based on 100% of market value.
3. Machinery &Tools- No change to the current rate of \$2.50 per \$100 of assessed valuation based on 100% of the market value rate.
4. Mobile Home Tax – No change to the current rate of \$ 0.68 per \$100 assessed valuation based on 100% of the market value.

Following the public hearing, the Board of Supervisors may fix an appropriate tax levy for real estate, mobile homes, personal property, machinery, and tools for the calendar year 2025. The Board of Supervisors is not obligated to adopt the proposed tax rates and may adjourn to subsequently meet and fix tax levies.
