

Tax Exemption by Designation – Charitable Organizations

Pursuant to the Code of Virginia § 58.1-3605, the King George County Board of Supervisors will hold a public hearing on Tuesday, July 01, 2025, at 5:30 PM in the Board Room, Revercomb Administration Building, 10459 Courthouse Drive, King George, VA 22485.

The purpose of the hearing is to receive public comment on proposed ordinances or resolutions granting tax-exempt status by designation to the following nonprofit charitable organizations: The 516 Project and Love Thy Neighbor.

Under Virginia law, the Board of Supervisors is authorized to grant exemption from local real and/or personal property taxes to qualifying charitable organizations by ordinance. Any such designation must follow a public hearing where citizens may express views for or against the exemption.
