

**NOTICE OF PUBLIC HEARING for
Application Z-2024-00184 Utility Scale
Solar Facility Siting Agreement**

Notice is hereby given that a public hearing will be held on Tuesday, July 15, 2025 at 5:30 p.m., or as soon thereafter as the matter may be heard, at the Revercomb Administration Building, 10459 Courthouse Drive, King George, VA 22485, by the King George County Board of Supervisors to consider approval of an Utility Scale Solar Facility Siting Agreement, as provided for in Virginia Code Sections 15.2-2316.6 through 15.2-2316.9, between King George County and, Open Road Renewables and Gibson Solar I, LLC, related to the a Utility Scale Solar Facility (combined with a Livestock Operation) on approximately 890 acres of private land (made up of 48 tax parcels) located in the Shiloh Magisterial District. The subject parcels are generally located adjacent to Kings Highway at the intersection of Big Timber Road and continue East for approximately 3 miles. Applicants have also requested a determination that the solar facility is "substantially in accord" with the County's Comprehensive Plan in accordance with Virginia Code §15.2-2232. Application Z-2024-00184.

The agreement would provide terms governing the development of the proposed Utility Scale Solar Facility and financial compensation to be paid to the County, in addition to tax payments, pursuant to Virginia Code Section 15.2-2316.7(B). Persons may appear and present their views at the public hearing.

A copy of the proposed Utility Scale Solar Facility Siting Agreement is available for public inspection during normal business hours (Monday through Friday, 8:00 a.m. until 4:00 p.m.) at the County Administrator's Office, located at 10459 Courthouse Drive, Suite 200, King George, Virginia 22485.
