Motion was made by **Supervisor Binder**, seconded by **Supervisor Sullins**, which carried **5-0**, to adopt the following resolution:

§33.2-325 & §33.2-912 - Addition of Public School Road to Secondary System & Abandonment with Replacement Road

WHEREAS, the King George County School Board has completed the construction of King George Middle School and this construction caused the relocation of Route 9951; and

WHEREAS, Route 9951 is assigned to add segments that provide access for school traffic from State Route 206 to King George Middle School; and

WHEREAS, construction of the new alignment is complete and meets standards deemed by the Department of Transportation appropriate for the traffic anticipated; and

WHEREAS, the project sketch and VDOT Form AM 4.3, attached and incorporated herein as part of this resolution, define adjustments required in the Secondary System of State highways as a result of construction; and

WHEREAS, certain segments of the old alignment identified on the incorporated Form AM 4.3 and identified to be abandoned are deemed to no longer serve public convenience warranting maintenance at the public expense; and

WHEREAS, the new alignment serves the same citizens as those portions of old road identified to be abandoned; and

WHEREAS, certain segments of the new alignment identified on the incorporated Form AM 4.3 are ready to be accepted into the Secondary System of State Highways.

NOW THEREFORE, BE IT RESOLVED, this Board hereby requests the Virginia Department of Transportation to take the necessary action to abandon those segments identified

on the attached Form AM 4.3 and project sketch as a part of the Secondary System of State Highways, pursuant to §33.2-912, Code of Virginia, 1950; and

BE IT FURTHER RESOLVED, this Board hereby requests the Virginia Department of Transportation to take the necessary action to accept those segments identified on the attached Form AM 4.3 and project sketch as a part of the Secondary System of State Highways, pursuant to §33.2-325, Code of Virginia, 1950; and

BE IT FURTHER RESOLVED, this Board requests the Virginia Department of Transportation to add the segments identified on the incorporated Form AM 4.3 to the Secondary System of State Highways, pursuant to §33.2-325 of the Code of Virginia; and

BE IT FURTHER RESOLVED, the School Board of King George County and this Board hereby guarantee the right of way to be clear and unrestricted, including any necessary easements for cuts, fills, and drainage; and

BE IT FINALLY RESOLVED, that a certified copy of this resolution be forwarded to the Virginia Department of Transportation.
