The King George County Board of Supervisors will hold a public hearing on Tuesday, October 21, 2025, at 5:30 p.m. in the Board Room of the Revercomb Administration Building, 10459 Courthouse Drive, King George, Virginia, to receive comments on the following:

Application Z-2025-00302, King George Mortuary Services/David Storke:

David Storke, on behalf of King George Mortuary Services, has requested the rezoning from A-2 (Rural Agriculture) to C-1 (Neighborhood Commercial) of approximately 27.5 acres of land. The property is located at 11089 James Madison Parkway and is further identified as a portion of Tax Parcel 25-110.

The King George County Planning Commission considered this application at its meeting on September 9, 2025, and voted 3:2 to forward a recommendation of approval to the Board of Supervisors.
