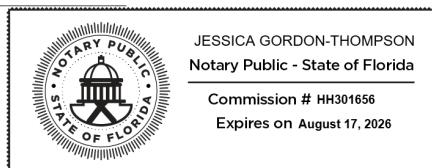

Notice is hereby given that a public hearing will be held on Tuesday, November 18, 2025 at 5:30 p.m., or as soon thereafter as the matter may be heard, in the Multipurpose Room at the Parks and Recreation Building, located at 8076 Kings Highway, King George, VA 22485, by the King George County Board of Supervisors to consider approval of an Solar Facility Siting Agreement, as provided for in Virginia Code Sections 15.2-2316.6 through 15.2-2316.9, between King George County and Caledon Solar, LLC, related to the Caledon Solar, LLC application for a Special Exception Permit ("SE") to allow for an Utility Scale Solar Facility, on certain real property in the County identified as County Tax Map 8-1, SE Application Z-2024-00240. The agreement would provide terms governing the development of the proposed Utility Scale Solar Facility and financial compensation to be paid to the County, in addition to tax payments, pursuant to Virginia Code Section 15.2-2316.7(B). Persons may appear and present their views at the public hearing.
