Fallen leaves and overgrown landscaping can obscure visibility and create hiding spots for unwanted intruders. Regularly schedule landscaping and maintenance services to keep your property's surroundings clean and well-kept. Trim shrubs, rake leaves, and ensure that all pathways and entrances are free of obstacles. Wet leaves also create a hazard in the fall by making sidewalks slippery. Later in the season, snow may mix with leaves to increase the risk of falling. Ensure your property is kept free of fallen leaves to prevent hazards at your residents. A well-maintained property not only enhances curb appeal but also discourages criminal activity.
