During the 2025 calendar year, the King George sheriff's Office was able to participate in several of our usual events like years previous such as the Special Olympics Polar Plunge, VA Special Olympics Torch Run, Bright Beginnings Back to School Program, Safe Harbor Child Advocacy Center "Save Jane" event, STEAM Night at KGHS, Annual Police Memorial Service, Wreaths Across America Day, Fire and Ice Challenge, Fall Festival, Trade School Boot Camp, CTE Program at KGHS, Career Day, Neighbor Watch Groups, Va.
